The last day to **withdraw** from the race is Thursday, **May 23, 2013**.

**Two members of the Board of Selectmen to serve for a term of three (3) years.**

**A Moderator to serve for a term of one (1) year.**

**A Town Clerk to serve for a term of three (3) years.**

**A Town Collector to Fill an Unexpired Term of one (1) year.**

**One (1) member of the Board of Assessors to serve for a term of three (3) years.**

**One (1) member of the Board of Health to serve for a term of three (3) years.**

**Two (2) members of the Library Trustees to serve for a term of three (3) years.**

**One (1) member of the Parks & Recreation Commission to serve for a term of three (3) years.**

**One (1) member of the School Committee to serve for a term of three (3) years.**

**One (1) member of the School Committee to serve an Unexpired term of two (2) years.**

**One (1) member of the Planning Board to serve for a term of five (5) years.**

**One (1) member of the Housing Authority to serve for a term of five (5) years.**

**One (1) member of the Housing Authority to Fill an Unexpired term of one (1) year.**
