Preliminary Application for Housing Rehabilitation Assistance

The Town of Clinton seeks to help income-qualified homeowners repair their homes. In order to qualify, *total household income must be less than the limits identified in the Table below*. These limits are based on the total number of people residing in a household.

Owners of rental properties may also be eligible to apply for assistance. Interested owners should fill out this form, and can contact the Community & Economic Development Office for more information.

Due to funding requirements, *eligible properties must be located within our Target Area*. A map of the Target Area is printed on the back of this application
